### Describe the program and why it fits the category. (20pts)

In November 2021, we created a unique webinar for our members in the Heartland Chapter. This webinar focused on the new Fannie Mae changes that were to take effective in January 2022. Our members were scrambling for information and resources to share with their communities. We wanted to get ahead of it and offer our members the most up to date information and resources so they could prepare for the significant changes ahead.

Our chapter is vast in geographic area covering the states of MO, KS, southern IL. We even have members in OK, AR and IA. It is difficult for our chapter to get in front of all our members to share this message. We felt having a webinar was the best viable way to reach our members to share these resources.

This topic was so important that we asked Dawn Bauman, VP of Government and Public Affairs at CAI Headquarters to be on our panel with our local expert attorney, Todd Billy, CCAL. We wanted to get this webinar out to as many members and prospective members as possible; we shared the information on our social media streams and made the webinar free to everyone a week after it aired. We strongly encouraged our management companies to push the message and resources out to their boards. We sent them the link to the recording and links to the resources provided during the webinar.

We felt this unique webinar fit the Public Affairs category.
