Describe the program and why it fits the category. (20pts)

We are not able to hold our Annual Conference in 2021 due to Michigan's COVID-19 restrictions on gathering together in large groups. The Chapter Board of Directors did not want to move the whole conference virtual. We had to put on our creative thinking hat to still provide a great networking and educational event to replace our conference. We decided to split the conference into three events. We hosted three live virtual mini expo and an in-person Great Outdoor Exhibitor Fair.

We were providing value and opportunities for our Business Partner to network in-person during a time they could not visit management companies. Also, we still had to meet our goal to provide opportunities for manager to earn enough CE every two year to recertify their designations.

We located Mill Race Village in Northville MI. It was a beautiful historic village. We felt our attendees would enjoy strolling through a beautiful historic village at our exhibitor fair while networking with colleagues and exhibitors.

We were able to rent the hole grounds for 6 hours, including set and cleanup time. We had to arrange for port-a-johns, handwashing stations, food trucks. education tent, chair, and table rentals.

We had to contact business and the city around the village to arrange additional parking for the attendees and exhibitors.

CAI member manager and homeowners were able to attend for free and non-member fee was \$50.00.

We sold out the exhibitor booths and sponsorships for this event.

How did this program meet the mission and vision of the chapters and CAI as a whole? (20pts)

CAI-MI's goal and purpose of the Michigan Chapter of CAI is to provide education and information to community association leaders and professionals while also providing the professional members with opportunities to market their services and network with other members.

CAI-MI is dedicated to helping Michigan's Community Associations build safer, more prosperous communities through education, legislation, and networking.

The Great Outdoor Exhibitor Fair met our mission and vision, by provided a CE education seminar, in-person networking for our Business Partner in-person networking and our LAC had a booth. - 1. The Chapter was able to bring this event over budget on the income and under budget with the expense. We budget for \$17,500.00 net profit and the event made \$26,058.56 net profit.

- 4. All the attendees, sponsors, and exhibitors requested that we hold this event again.
