Cancellation Policy: Full refunds will be issued if written cancellation is received on or before Dec. 9, 2016. Cancellations received between Dec. 10–20, 2016, are subject to a 50% administrative fee. Registration fees are not refundable after Dec. 20, 2016. CAI Suitcasing Policy: CAI has a no-tolerance policy regarding "suitcasing," which describes the practice by nonexhibiting companies or individuals of soliciting sales or sales leads in the aisles, or in the lobbies, and/or representing their services or soliciting seminar participants including social activities. Nonsponsoring suppliers participating in the seminar as attendees or speakers are prohibited from soliciting business in or after sessions or in the seminar hotel.

Private Party Policy: All hospitality suites and hosted events must be reserved, approved and paid for through CAI. Hospitality suites/hosted events are not permitted during official conference activities. Nonexhibiting suppliers are not permitted to host events at the official hotel during the conference.

Violators of these policies will be ejected from the show, if exhibiting, and charged the tabletop sponsorship rate (\$2,100), which must be paid prior to registering as an attendee, exhibitor or sponsor at any future CAI conference or other event.
